WHILE WORKING TO OPEN A RESIDENTIAL CHILDREN'S HOSPICE AND RESPITE HOME, IT HAS BEEN A STRATEGIC PRIORITY OF CRESCENT COVE'S TO SUPPORT FAMILIES CARING FOR CHILDREN WITH LIFE-THREATENING CONDITIONS.
