IN 2018, CRESCENT COVE WORKED CLOSELY WITH THE DEPARTMENT OF HEALTH TO ENSURE THE FACILITY MET ALL REGULATIONS NECESSARY TO BE LICENSED AS A RESIDENTIAL HOSPICE. WHILE MAJOR RENOVATIONS WERE COMPLETE AT THE START OF THE YEAR, A NUMBER OF ADJUSTMENTS NEEDED TO BE MADE SUCH AS CHANGING THE LAUNDRY INTO A MEDICATION PREPARATION SPACE, TRANSITIONING ONE OF THE WALK-IN SHOWERS TO A LAUNDRY ROOM AND ADDING A SINK TO THE NURSES STATION. THESE ADJUSTMENTS HAD TO FIRST BE APPROVED BY THE CITY OF BROOKLYN PARK AND THEN BY THE DEPARTMENT OF HEALTH.
