# Speakers



**Elaine Allen** has been a registered nurse for 48 years, working with children, teens, and adults with developmental, physical and medical challenges in family homes, group homes, camps, schools, and day programs. She's taught medication administration to group home and day program staff. She also performed utilization reviews of group homes in Central Minnesota. Her volunteer connection to Crescent Cove

spans the last eight years through her life experience with her granddaughter Maryah. You can read Maryah's story on the Crescent Cove website.



**Ted Bowman** is an educator, author and consultant who specializes in change and transition. He is an adjunct faculty member at the University of St. Thomas, teaching a graduate social work course on grief and loss. Ted was senior trainer for the Wilder Foundation and taught family education courses at the University of Minnesota. Ted has published more than 80 articles, chapters, booklets, and poems.

He received the Minnesota Council on Family Relations Distinguished Service to Families Award in 1979, the Friend of the Network Award from the Minnesota Vocational Consumer and Family Education Network in 1988, and the St. Paul Civitan Club Clergy Award in 1994.



**Todd Dalberg** is a pediatrician and palliative medicine physician at Gillette Children's Specialty Healthcare, specializing in neuropalliative care. His research has focused on improving integration of palliative care and oncology. Todd trained at the University of New England College of Osteopathic Medicine, and earned a Master's of Clinical Research from Oregon Health & Science University. His residency was at Connecticut

Children's Medical Center and completed a fellowships at the Oregon Health & Science University and the Akron Children's Hospital.



**Jonathan Cottor**'s son Ryan was diagnosed with Spinal Muscular Atrophy at eight months old. They were told there was an 80% chance he would not survive to his second birthday. Their family was the inspiration and founding force to bring Ryan House to fruition in Phoenix, Arizona. Living in London at Ryan's birth, they were referred to Helen House in Oxford. After returning to Arizona in 2003, Ryan House

opened its doors in March 2010. Jonathan is co-founder, first board chair, and ongoing board member of Ryan House, and a 30-year corporate marketing and sales expert. His wife of 26 years, Holly, and he are excited to transition their sons Ethan and Ryan into adulthood.



**Tiffany DeRoma** is a mother of four from Lakeville, Minnesota. Her daughter, Ellie, passed away at nine months old in 2010 from sepsis and functional asplenia. Her surviving children include Max, 9, who has special needs, and twins, Addy and Levi, 6. Tiffany and her husband, Dave, started non-profit Ellie's Light after Ellie died to comfort those experiencing the loss of a child and those with critically, terminally, and

chronically-ill children. Before having children, Tiffany worked as a pediatric oncology and hematology RN.



**Peter Everson** joined Sunrise Banks in 2006 and is the branch manager of the bank's University Avenue location in St. Paul. Peter specializes in relationship banking with consumers and small businesses. He attended Saint Olaf College and is a graduate of the Graduate School of Banking in Madison, Wisconsin.



Leah Golberstein is a former academic and an artist who has extensive training in teaching mindfulness meditation; in particular, in teaching meditation to trauma sensitive populations. Leah has worked with cancer and cardiac patients, families and care givers of hospice patients, at-risk teenagers, and individuals seeking relief from anxiety. Leah has graduate degrees in both theoretical mathematics and in

visual studies, and is a former faculty member of the Minneapolis College of Art & Design.



Jeannie Goodspeed is mother to three children, Greta, 12, Simon, 6, and Ivy, who died in 2014 at age 5. Ivy was a beautiful girl with complex medical challenges and disabilities. Jeannie learned so much from Ivy during her short life; lessons about patience, acceptance, living in the moment, and finding peace and fulfillment in an imperfect life. Jeannie works part-time as a pediatrician for HealthEast at the Tamarack Clinic in

Woodbury. She is also an aspiring writer and is working on a memoir to share her family's story of choosing palliative care for Ivy. Jeannie lives in St. Paul with her husband Neil and their children.



**Dave Hecker** has been in the construction industry since 1994 doing both commercial and residential work. He is currently a principle at Gardner Builders, a commercial general contractor. His role includes HR, office operations and project management. Dave was Crescent Cove's construction project manager and was instrumental in helping Crescent Cove open its doors.



**Teri Kwant** brings a unique perspective and process to clients like Crescent Cove or Dakota County. Katie Lindenfelser is a music therapist, massage therapist, and reflexologist who has worked with children and young adults with a shortened life expectancy and their families in the hospital, hospice, and home care setting. Katie went to Melbourne, Australia to pursue a master's degree researching music therapy and pediatric palliative care. In the fall of 2008 she returned again to Australia to provide music therapy at

Very Special Kids Children's Hospice. Katie is the founder of Crescent Cove and serves as its executive director.



**Melanie Majerus** is a product development director at UnitedHealthcare, working on the Special Needs Initiative that helps families and caregivers of children with special needs navigate a complex healthcare system. She joined the team in 2017, and is responsible for testing innovative solutions that can help UnitedHealthcare members improve the quality of life for their families. Melanie is thrilled to

have found a job that aligns to her purpose in life.



**Erich Mische** is the executive director of Spare Key, a local Minnesota nonprofit whose mission is to provide assistance to families in crisis with critically ill or seriously injured family members through housing grant payment assistance, engaged resource referrals, and advocacy. From its founding in 1997 to 2016, Spare Key has helped over 3,000 families with nearly \$3 million in housing grants.



**Grant Mohwinkel** was raised in Rosemount, Minnesota and enjoys volunteering with Crescent Cove whenever possible. Grant says it is important for him to stay close with Crescent Cove and help out any way he can as it helps him feel connected to his sister Jennie, who died of Sandhoff disease in 1994 at age 10. Growing up with Jennie is the main reason why Grant believes in Crescent Cove's mission. In his free

time, Grant enjoys taking walks/hikes with his fiancé, Maddy, and puppy Hobbs! He is an avid golfer and Minnesota sports enthusiast, so he spends a lot of free time frustrated.



**Mark Ostrom** founded Circle design to focus on an underappreciated and overlooked aspect of wellness, that being physical space. Facilities and families do not typically have the funds to address ongoing space needs and any "extra" dollars will likely first go to support services, living expenses, or insurance. Circle design bridges the gap by bringing stellar design teams together to surround sick kids with cool space.

As the ring leader, Mark's primary responsibilities are listening, dreaming and getting stuff done. Mark's project of note is the original Rainforest Café; the #1 grossing sales restaurant in the world, where no one goes for the food.



**Michele Peterson** is a pediatrician who currently practices at Central Pediatrics. She attended medical school and residency at the University of Minnesota. Long before entering medical school, she had the pleasure of babysitting and becoming the personal care attendant for a beautiful little girl, Jennifer Mohwinkel. Jennie was born on Halloween and was perfect in every way. Around the time she was three years old, she started

to miss some of her development milestones. She eventually was diagnosed with a rare neurodegenerative disease, Sandhoff's, and subsequently died at age 10. Michele supported and cared for Jennie for over five years, until her passing in her home. Her time with Jennie forever changed the pediatrician she would become and is the reason she believes so strongly in the mission of Crescent Cove.



**Stacy Remke** is an instructor at the University of Minnesota School of Social Work, teaching in areas of health, disabilities and aging, integrative behavioral/mental health and interprofessional collaborative practice. Her clinical experience includes 27 years as a pediatric palliative care social worker, assisting children with life-threatening and/or chronic, complex conditions and their families in-home and in community-based settings

settings, as well as in the hospital. She served on the national Advisory Board for NHPCO's ChiPPS Pediatric Hospice and Palliative Care interest group. Stacy is on the board for Social Work in Hospice and Palliative Care Network and is currently engaged with advancing the practice of social work in hospice and palliative care, which are, by definition, inter-professional settings.
